- 14 days hospitalization including ICU stay.
- Donor hepatectomy and 7 days hospitalisation
- All regular medicines used for liver transplant patients.
- Albumin, Anti viral therapy is NOT included.
- All immunosuppressive medicines
- Professional charges
- Operation charges
- Blood Transfusion charges up to Rs.3 lakhs
- Blood and blood products, during and after transplantation.  
(All blood products are screened for HIV, HbsAg, HCV, VDRL, MP, CMV IgG, EBV VCA IgM, BV EBNA IgM, HTLV-1, Anti HBC, Anti Hbs Ab).
- Platelet donors and blood donors will have to be mobilized by the patient's family as per the specifications received from the Blood Bank In-charge.

**III.** The amount payable under the above said package/scheme is confined only to the treatment and other facilities etc. which are specifically and detailedly mentioned in the aforesaid clauses I,II and if any extra treatment is required ,in the event of any infection, repeated culture and sensitivities, repeated blood and urine investigations, special medications like Zygris, Interferon, Liposomal Amphotercin-B, Zenapax, Novaseven, Re-exploration surgery, Immnuoglobulins and requirement of MARS, CRRT, renal dialysis, CT, MRCP, MRI, Nuclear Medicine and any special interventions, which is not a part of a routine liver Transplant, used after discussion with the patient and his/her family will be extra as per actuals and they shall be responsible for all extra and additional charges, expenditure and costs if any incurred by the Hospital. The patient his/her family shall promptly bear all the said extra and additional expenditure costs, charges etc., in the event of continuation of treatment to the patient.

**IV.** Special drugs used after transplantation

**In the even of any infection, special medication like zygris, interferon, Liposomal Amphotericin-B, Zenapax.**

**Payment :**

**1) Package**

- The Full amount of the package/profile should be paid at the time of admission.
- Package/profile cost is fixed, and under no circumstances can the patient claim refund for lesser number of tests performed than provided for in the package/profile.
- Package/profile break up costs cannot be provided.

2) The liver transplant package fee (SI and II ) to be paid while the patient is getting on to the active list for transplant. Any refunds or additional payments will be taken care during the course of admission as and when required at the time of discharge of the patient.

3) Any special drugs that are required to be used during and after the transplant will be dispensed against the deposit of Rs. 5 Lakhs made by the patient at the time of admission for transplant. Any excess payments to be made by the patient will be intimated as and when required.

4) In view of current pandemic, usage of safety consumables & PPE will be charged extra approximately Rs.1 lakh

5) Post transplant (post discharge) medication that would be required for life long is not included in the package.
